Record is put up by petition.

Accused person Noor Islam Molla, surrenders today and prays for bail. He is taken into custody and remanded to J.C. till date.

Learned advocate for the accused submitted that as per order of this court vide No. 2, dated 04.07.2026 the accused has paid 50% of the pilferage amount of Rs.1,93,950/- out of total pilferage amount of Rs.3,87,899/-. He prays for bail on any terms and conditions.

Learned advocate for the accused further prays for paying the rest pilferage amount in three monthly installments.

Learned P.P.-in-charge and the learned advocate for the WBSEDCL raised no objection.

Original receipt vide No. 127806529064 dated 07.07.2026 shows that the accused Noor Islam Molla has paid pilferage amount of Rs.1,93,950/- out of final assessment bill of Rs.3,87,899 /- of the WBSEDCL dated 02.07.2026.

Considering the submissions of the learned advocate for the petitioner and the learned advocate for the WBSEDCL, and in the interest of justice, I am of the view that it will be justified to permit the petitioner, namely, Noor Islam Molla to deposit the rest pilferage amount i.e. [Rs.3,87,899/- (-) Rs.1,93,950/-] Rs.1,93,949/- as incurred by WBSEDCL in three (3) equal monthly installments. The petitioner is further directed to deposit the said amount by 15th on every month. Hence, the WBSEDCL is directed to accept the rest pilferage amount, in three monthly installments from petitioner.

Considering above, the accused Noor Islam Molla may find **A.I. bail of Rs.2,000/-** with one surety, to the satisfaction of the learned C.J.M, Barasat i.d. to J.C. He is further directed to pay the rest pilferage amount as above.

With the above observations the petition dated 09.07.2026 filed on behalf of the said accused person is disposed of.

Fix 13.11.2026 for appearance of the accused Noor Islam Molla with payment receipts and report in final form.

Let a copy of order be sent to the Ld. CJM, Barasat, for information and taking necessary action.

Let another copy of this order be handed over to Mr. S. Mitra, learned advocate for the WBSEDCL for communicating the same to the Station Manager of Minakhan CCC of the WBSEDCL.

No need to put up the record on 17.07.2026.
