[No. XXVIII(II) Schedule V, Act V, 1898]

(Section 221, 222, 223 Code of Criminal Procedure)

2. Name of accused Matal @ Biswajit Munda

hereby charge
you as follows :

First, that you, on 02.02.2014 at about 09.00 a.m. at Village Janapul, Maniktala, under P.S. - Habra, North 24 Parganas used criminal force to the victim (name withheld) of the village mentioned above with an intent to disrobe her and that you thereby committed an offence punishable under section 354B of Indian Penal Code and within the cognizance of this Court of Sessions.

Secondly, that you on 02.02.2014 at about 09.00 a.m. at Village Janapul, Maniktala, under P.S. - Habra, North 24 Parganas used criminal force to the victim (name withheld) of the village mentioned above and committed rape on her and that you thereby committed an offence punishable under section 376 of Indian Penal Code and within the cognizance of this Court of Sessions.

And I hereby direct that you be tried by this Court on the said charge.

The charge so framed has been read over and explained to the accused person and he pleaded not guilty and claimed to be tried.

Prosecution has brought allegations under sections 354B/376 of the IPC against the accused person.

Upon consideration and hearing of the prosecution and the defence, I find that there is sufficient ground for proceeding. The allegations under section 286/304 IPC are prima-facie established against the accused person.

The substance of accusations have been read over and explained to the accused person and he pleaded not guilty and claimed to be tried.

A formal charge in Form 32, Schedule- II of the Code of Criminal Procedure is prepared and is on record.
