Order no. 01 dated 07.02.2025:

The application for bail is taken up for hearing.

Hd. Ld Advocate for the petitioner, Jahangir Mondal @ Md. Jahangir Islam who submitted that his client has been falsely implicated and his client is not at all Jahangir Mondal, but Md. Jahangir Islam and his father's name is not Rashid Mondal, but Md. Abdul Rashid. He would submit that his client is innocent and has no connection with the instant case and he has been falsely implicated in this case. He would further submit that his client is a para teacher in a Government sponsored educational institution and in support of his contention, the ld lawyer for the petitioner files some documents such as one xerox copy of aadhar card in the name of Md. Jahangir Islam, m xerox copy of aadhar card in the name of Md. Abdul Rasid, attendance certificate issued by the Headmaster, certificate issued by the District Project Officer, copy of experience certificate, xerox copy of engagement letter, xerox copy of pan card of father of Md. Jahangir Islam and pan card of Md Jahangir Islam, voter I.D card of bth Md. Jahangir Islam and his father, copy of certificate issued by Head Master and copy of intimation to the officer in charge along with firsti. He prays for bail on any condition.

Ld. Special P.P submitted that such prayer is not tenable since W.P.A has been issued by the ld Magistrate and case has been split up for the present and at that stage, he has been arrested. He submitted that he is involved in a heinous crime. He opposes the bail petition.

Considered.

The chargesheet goes to suggest that the same was filed by showing this accd as absconder. The name of this accd as well as his father's name is much resemblance with the name reflected in the chargesheet and at this stage, this Court finds no reason to believe that a stranger has been brought under arrest. Moreover, the prosecution in the forwarding report discloses his name as Jahangir Mondal @ Md. Jahangir Islam, S/O- Rashid Mondal.

Considering the seriousness of the allegation and other materials available in the C.D, this Court is not inclined to set him at liberty of bail. Hence, his bail petition stands rejected.

At this stage, the ld Special P.P by forwarding the application submitted that for recovering more arms and ammunitions and deadly weapons and unearthing conspiracy and to arrest other co-accd persons, seven days' P.C prayer of this accd may be allowed.

Ld. Advocate for the defence raises objection.

The prosecution has filed the chargesheet on 05.12.2024 by showing this accd as absconder and one supplementary chargesheet dt 07.01.2025 has also been filed wherein this accd is named at serial no.11 and no further investigation in respect of this accd has ben prayed for.

Considering that the investigation has already been completed and the matter has been fixed for commitment, the Court finds no reason to allow the P.C prayer. Hence, the same stands rejected.

To date I.e on 14.02.2025 for production of this accd from J.C. as well.
