Record is put up today on the strength of put up petition filed on behalf of accused person, namely, Siddik Sardar same is allowed considering the urgency of the matter. Another petition is filed on behalf of the said accused person in which he prays for permitting him to surrender before this court .

Learned advocate for the said accused person is present.

Learned Public Prosecutor-in-charge of this case is present.

Learned advocate for the WBSEDCL is present.

Learned advocate for the said accused person has submitted that in this case FIR was lodged against this accused person on 29.08.2024 alleging commission of the offence punishable under section 135 of the Electricity Act 2003. He prays for permitting the said accused person to surrender before this court.

Learned Public Prosecutor-in-charge of this case has not objected the said prayer of the accused person and left the matter upon this court to pass appropriate order.

I have heard the submission of the learned advocate for the accused person and learned Public Prosecutor-in-charge of this case and perused the records. From the records it is revealed that FIR was lodged against this accused person on 29.08.2024 alleging commission of the offence punishable under section 135 of the Electricity Act, 2003. Considering the said facts I am of the view that it will be justified to permit the accused person to surrender before this court. Hence, the petition dated 08.10.2024 filed on behalf of the said accused person is allowed.

Accused person, namely, Siddik Sardar surrenders before this court, he is taken into custody and remanded to J.C. till 15.10.2024.

One bail petition is filed on behalf of the said accused person.

On consent of both parties the bail petition filed on behalf of the said accused person is taken up for hearing.

Learned advocate for the said accused person has submitted that there are allegations against this accused person for commission of the offence punishable under section 135 of the Electricity Act, 2003 and the said accused person deposited amount of Rs.19,286/-. He files receipt No. 130305640460 dated 03.09.2024 issued from WBSEDCL. He prays for enlarging the said accused person on bail on any condition.

Learned Public Prosecutor-in-charge of this case has not objected the said prayer of the accused person and left the matter upon this court to pass appropriate order.

I have the heard the submissions of the learned advocate for the said accused person and the learned Public Prosecutor-in-charge of this case and perused the records including

C.D. From the records it is revealed that FIR was lodged against this accused person on 29.08.2024 alleging commission of the offence punishable under section 135 of the Electricity Act, 2003 and the said accused person deposited the amount of Rs.19,286/- as per the assessment of the WBSSEDCL and in that respect learned advocate for the accused person filed final assessment bill dated 29.08.2024 and receipt dated 03.09.2024. Considering the materials on record I am of the view that it will be justified to enlarge the said accused person on bail on following conditions :

- (a) Accused person will appear in each and every proceeding of this case;
- (b) Accused person, namely, Siddik Sardar will furnish bail bond of Rs.2000/- with one registered surety to the satisfaction of learned CJM, North 24 Parganas, Barasat.

With above observations the bail petition dated 08.10.2024 filed on behalf of the accused person, namely, Siddik Sardar is disposed of.

If on bail to date i.e. 02.06.2026 for appearance, report in final form.

Let a copy of order be sent to the Ld. CJM, Barasat, for his information and taking necessary action.
