Record is put up today on the strength of put up petition filed on behalf of accused person, namely, Nabir Ali Molla same is allowed considering the urgency of the matter. Another petition is filed on behalf of the said accused person in which he prays for permitting him to surrender before this court .

Learned advocate for the said accused person is present.

Learned Public Prosecutor-in-charge of this case is present.

Learned advocate for the WBSEDCL is present.

Learned advocate for the said accused person has submitted that this accused person was enlarged on bail by this court on 28.01.2022 and due to misuse of liberty, warrant of arrest was issued against this accused person on 26.07.2024. He prays for permitting the said accused person to surrender before this court.

Learned Public Prosecutor-in-charge of this case has not objected the said prayer of the accused person, and left the matter upon this court to pass appropriate order.

I have heard the submission of the learned advocate for the said accused person and learned Public Prosecutor-in-charge of this case and perused the records. From the records it is revealed that against this accused person warrant of arrest was issued on 26.07.2024, in this circumstances it will be justified to permit the said accused person to surrender before this court, hence prayer of the said accused person to permit him to surrender before this court is allowed.

Accused person, namely, Nabir Ali Molla surrenders before this court, he is taken into custody and remanded to J.C. till 27.12.2024.

One bail petition is filed on behalf of the accused person, namely Nabir Ali Molla. On consent of both parties the said bail petition filed on behalf of the said accused person is taken up for hearing.

Learned advocate for the said accused person has submitted that due to diary mistake the said accused person has not appeared on the last dates due to that reason warrant of arrest was issued against him. He prays for enlarging the said accused person on bail.

Learned Public Prosecutor-in-charge and learned advocate for the WBSEDCL have not objected the bail prayer of the said accused person, and left the matter upon this court to pass appropriate order.

Considering the submissions of learned advocate for the accused person that due to diary mistake the said accused person has not appeared before this court on the previous dates that is not intentional. With above observations and considering that the said accused person was already on bail, I am of the view it will be justified to enlarge the said accused person on bail on following conditions :

- (a) Accused person, namely Nabir Ali Molla, will appear in each and every proceeding of this case,
- (b) Accused person, namely, Nabir Ali Molla, will furnish bail bond of Rs.2000/- with one registered surety to the satisfaction of learned CJM, North 24 Parganas, Barasat.

With above observations the bail petition dated 24.12.2024 filed on behalf of the accused person namely, Nabir Ali Molla is disposed of.

To date (11.07.2025) for production/appearance of the accused person, Nabir Ali Molla and E.R. of W.A. against another accused.
