Record is put up by petition.

Accused Rabiul Molla and Nizamuddin Molla surrender before this court and pray for bail.
They are taken into custody and remanded to J.C. till 20.08.2025.

Learned advocate for the said accused person is present.

Learned advocate for the WBSEDCL is present.

Learned Public Prosecutor-in-charge is present.

Learned P.P.-in-charge and the learned advocate for the WBSEDCL submitted that out of total pilferage amount of Rs.95,492/- the accused Rabiul Molla has not paid any pilferage amount. They have further submitted that out of total pilferage amount of Rs.83,574/- the accused Nizamuddin Molla has not paid any pilferage amount.

Learned advocate for the accused person, namely, Rabiul Molla and Nizamuddin Molla, prayed for depositing the pilferage amount in two equal installments and they are unable to pay the said finally assessed pilferage amount at a time.

Learned advocate for the WBSEDCL has not objected the said prayer of the learned advocate for the accused person, and prays for passing appropriate order.

I have heard the learned advocate for the said accused person, learned advocate for the WBSEDCL and perused the records.

Considering the submissions of the learned advocate for the said accused person and the learned advocate for the WBSEDCL, and in the interest of justice, I am of the view that it will be justified to permit the said accused person namely Rabiul Molla and Nizamuddin Molla to deposit the finally assessed pilferage amounts in two equal monthly installments. The accused persons are further directed to deposit the 50% of the pilferage amount on 01.08.2025 and rest pilferage amount on 01.09.2025. Hence, the WBSEDCL is directed to accept the assessed pilferage amount, in monthly installments from accused person with effect from 01.08.2025.

With the above observations the petition dated 18.07.2025 filed on behalf of the said accused person is disposed of.

Petitioner Rabiul Molla and Nizamuddin Molla may find **A.I.bail** of Rs.2,000/- each with one surety each to the satisfaction of the learned C.J.M, Barasat i.d. to J.C.

If on bail fix 20.08.2025 for appearance of the accused persons with payment receipts.

Let a copy of order be sent to the Ld. CJM, Barasat, for his information and taking necessary action.

Another copy of this order be handed over to the accused Rabiul Molla and Nizamuddin Molla separately, for producing the photocopy of the same before Rajarhat CCC of the WBSEDCL authority at the time of payment of money as per order.
