Today is fixed for appearance of the accused on Court bail and appointment of the Public Prosecutor / Additional Public Prosecutor in-charge of the case.

The Ld. PP-in-Charge Shri Bikash Halder is present by filing hazira.

Out of nine (09) accused eight (08) accused are present by filing hazira and another (01) accused Sujit Bairagi is absent without taking any steps.

The Ld. Advocate Shri Ashok Kumar Pramanick has submitted that he would not take any steps on behalf of the accused Sujit Bairagi since he has not been contacting him since long.

It is now 1-25 P.M.. On repeated calls the accused Sujit Bairagi is found absent and no steps is taken on his behalf and as such warrant of arrest is issued against the accused.

The Bench Clerk is directed to issue warrant of arrest against the accused Sujit Bairagi at once.

Due to the default of the accused Sujit Bairagi in making appearance before the Court the amount of Rs. 1,000/-, bound by the sureties Pralay Kumar Bhowmick and Anil Kumar Pramanick to forfeit to the Government on breach of bond executed by them, are forfeited and consequently, said bonds are cancelled and accordingly, start proceeding under section 446, Cr.P.C. against the sureties concerned.

Let a copy of this order along with original bail bonds be sent to the Ld. ACJM, Bongaon with a request to start proceeding under section 446 CrPC against the concerned sureties and inform this Court about the said proceeding number.

The Bench Clerk is directed to do the needful at once.
