Today is fixed for appearance of the accd. persons. E.R. of W.A. of the accused Shyamapada Roy and S.D.T.

Out of seven accd. persons, five accd. persons, namely Shambhu Nath Sarkar, Sitaram Roy, Sailen Roy Biplab Biswas and Hemanta Biswas on Court Bail are present and have filed their haziras.

Accused Biswajit Roy is absent by filing a petition through his Ld. Advocate praying for time stating therein that due to his illness, the petitioner accused Biswajit Roy could not appear before the Court today and prayed for another date to be present before this Court.

Ld. P.P.-in-Charge takes no step.

Ld. Defence Counsel on behalf of the accused person Shyamapada Roy prayed for bail on the ground that this accused was absent to appear before this Court and for that reason W.A. was issued against him. Today the accused surrendered before the Court and prayed for bail on the ground that he was out of station for his job purpose as well as for his livelihood.

None has been appeared on behalf of the State to raise objection against the bail petition.

From the record, it has also been appeared that the trial has already been started but non-appearance of the Ld. P.P., this case could not be proceeded without any delay.

Considering the present situation, the accused person namely Shyamapada Roy have been released by furnishing a P.R. bond of Rs. 1500/- subject to the satisfaction of the Ld. A.C.J.M., Bongaon, district North 24 Parganas. Accordingly the order of issuance of Warrant of Arrest against the accused person namely Shyamapada Roy has been recalled.

Fix 01-07-2023 for appearance of the all accused persons, appointment of Ld. P.P. and for S.D.T.
