Today is fixed for appearance of the accused persons, appointment of Ld. P.P. and for further order.

The accused persons namely 1) Shyamapada Roy, 2) Shambhu Nath Sarkar, 3) Hemanta Biswas, 4) Sitaram Roy, 5) Sailen Roy, 6) Biplab Biswas, 7) Biswajit Roy on Court bail are present and file hazira along with their respective Ld. Advocates.

Ld. P.P. Pradip Kr. Chatterjee takes no step.

It appears from the record that this case was filed on **05-06-2009**. Thereafter, the Addl. District & Sessions Judge, 1st Court, Bongaon, North 24 Parganas sent the record to this Court for its trial and this Court received the case record on **15-12-2015** for its trial and disposal. Thereafter **charge was framed on 23-02-2016 u/s. 341/302/34 IPC**. **On 10-05-2016, the evidence of PW-1** Arjun Sarkar was started and completed and till 27-09-2019 total nine (9) witnesses were examined and cross examined out of total 18 Charge sheeted witnesses. Since 12-04-2022 the Ld. P.P. of this case Sri Pradip Chatterjee takes no step and since then this case is running for appearance of the accused persons and for S.D.T. Till today, 10 dates have already been fixed for S.D.T. but the Ld. P.P. takes no step. As a result of it, the accd. persons are suffering day after day and no fruitful results are gained by them in this case.

In view of the above, it seems that the Ld. P.P. is very much reluctant to produce the prosecution witnesses on behalf of the State and this Court is unable to understand as to why the State has obtained the delatary tactics to proceed with this case.

As this case was started on 05-06-2009, G.R. 930 OF 2009 and for the act on behalf of the State, the litigant public are suffering a lot, though 9 witnesses were examined and cross examined in this case and it is very much expensive also for the accused persons to appear before this Court without any fruitful result.

In my view, the prosecution / State should be more and more diligent to proceed with this case very sincerely for the interest of the litigant public. However, the prosecution is hereby earnestly requested to proceed with this case accordingly by serving of summons upon the prosecution witnesses.

The concerned Ld. P.P. is hereby earnestly requested to take all necessary steps to proceed with this case at the earliest.
