The record is put up today along with a put up petition filed by the Ld. Lawyer for the accused person, namely Hasanur Jaman Mondal along with a fresh Vakalatnama prying for bail of the accused person Hasanur Jaman Mondal.

The sole accused person, namely Hasanur Jaman Mondal has surrendered before the Court and pray for bail with a fresh Vakalatnama.

The Ld. Advocate for the accused person Hasanur Jaman Mondal by filing a bail petition, prayed for bail as the accused person Hasanur Jaman Mondal was absent before the Court, for which the W.A. was issued against the accused Hasanur Jaman Mondal. The Ld. Advocate for the accused stated that the accused person has been falsely implicated in this case and the allegations against him are false and fabricated.

After perusal of the record, it appears from the record that since 03-05-2023 this accused person is absent from this court without any step, while the other accused persons are present before this Court. Thereafter, on 04-05-2023, 24-07-2023, 25-07-2023, 16-10-2023, 17-10-2023, in total five consecutive dates the accused person Hasanur Jaman Mondal al has not appeared before this Court and none takes steps on behalf of the accused person Hasanur Jaman Mondal and in such situation, WA was issued against the said accused Hasanur Jaman Mondal on 17-10-2023 vide order No. 19 of this Case. Today the accused has surrendered before the Court and the Ld. Advocate for the accused has filed the bail petition on behalf of the accused Hasanur Jaman Mondal.

I have perused the case record. As the accused person has surrendered before the Court after issuing Warrant of Arrest, as such, the bail prayer of the accused person Hasanur Jaman Mondal is hereby considered and allowed as an **interim bail**.

The accused person Hasanur Jaman Mondal may find a bail of Rs. 10,000/- with two sureties of Rs. 5000/- each, **one should be the local surety**, subject to the satisfaction of the Ld. A.C.J.M., Bongaon. i.d. remanded to J/C and for appearance of the accused if he is on bail on the next date.

Fix 06-05-2024 for appearance of the accused person Hasanur Jaman Mondal, if he is on bail and further order.

Thus the put up petition is hereby disposed off.
