ORDER

Case called out. Complainant present. Complainant counsel heard. Sworn statement recorded complainant examined as PW-1 got marked as Ex.P.1 to P.5. I have perused the complaint and documents produced by complainant. Sworn Statement is recorded. His Sworn Statement corroborates the contents of the complaint and he has produced the 1 cheque -Cheque bearing No.000007, Bank endorsement, Legal notice, Postal receipt Returned RPAD Cover, (Ex.P.1 to P.5). His Sworn Statement prima-facie establish that the accused has committed offence punishable U/s.138 of N.I Act. Therefore, the material placed on record by the complainant at this stage are sufficient to proceed against the accused for the offence U/s.138 of NI Act.
