COMMITTAL ORDER

The Police Inspector of Woman Police Station, Vijayapura has filed charge sheet against the accused No.1 and 2 for the offences punishable under Section 376(2)(J)(N), 313, 354-D, 504, 506 r/w 34 of IPC.

This Court has taken cognizance for the offences punishable under Section 376(2)(J)(N), 313, 354-D, 504, 506 r/w 34 of IPC against the accused. The accused No.1 is in judicial custody from the date of his arrest and accused No.2 is on bail. The copies of charge sheet and other papers have been furnished to the accused in compliance of Sec.207 of Cr.P.C.

The offences alleged against accused under Section 313, 376(2)(J)(N) of IPC are triable by the Court of Sessions. Therefore, it is just and necessary that the case has to be committed to the Hon'ble Court of Sessions, Vijayapura. Hence, this Court proceed to pass the following;

ORDER

Acting U/s.209 of Cr.P.C., the case against accused No.1 and 2 stands committed to the Hon'ble Court of Sessions Vijayapura for trial.

It is directed to jail authority to produce accused No.1, whenever called by Hon'ble District and Sessions Court, Vijayapura.

The accused No.2 shall execute personal bond for Rs.1,00,000/-.

The accused No.2 is directed to appear before the Court of Sessions after receiving the summons from the said Court.

Office to henceforth submit the entire records and articles of the case to the Hon'ble Sessions Court Vijayapura and that the case properties, if any, shall be submitted as and when called for, by the said court.

Office to notify the Public Prosecutor Vijayapura regarding Committal of the case to the Sessions Court.
