Accused **Gopal Karmakar** is produced from J.C. and remanded to J.C. till next date.

Ld. PP in-charge is also present.

The case is taken up for consideration of charge.

Heard both sides.

Perused the materials on record.

After consideration of the materials on record and hearing both sides I am of the opinion that there is ground for presuming that the accused person named above has committed the offence punishable u/s **417/376/493 of IPC** and this court is competent to try the case and adequately punish the accused person.

Accordingly charge is framed in separate sheet against the accused person named above for the offence punishable u/s **417/376/493 of IPC**.

Charge so framed is read over and explained in vernacular to the accused person to which he pleaded not guilty by saying "Ami Nirdosh" and claims to be tried.

Formal Charge be kept with the record.

The case be numbered as **Sessions Trial No.03(09)2023.**

Fix **14.05.2024 for evidence of CSW 1 & 2**

15.05.2024 for evidence of CSW 3 & 4

16.05.2024 for evidence of CSW 5 & 6

17.05.2024 for evidence of CSW 7 & 8

18.05.2024 for evidence of CSW 9 & 10

Issue summons accordingly.

In view of the judgment dated 12.12.2022 passed by the Hon'ble High Court, Calcutta in connection with CRR No. 854 of 2011, let a copy of this order be transmitted to the O.C. of the concerned P.S. so that I.O. of this case or any competent officer of the P.S. remains present along with the witnesses of this case on the dates fixed.

One bail petition is filed for the accused person.

Copy served.

Bail petition is moved.

Heard Ld. Advocate for both sides.

Considered.

Ld. Advocate of the accused person submits that the accused is in J.C. since 27.07.2023, he is innocent and has falsely been implicated in this case. There is no chance of his absconsion. Ld. Advocate for the accused person prays for bail on

any terms and conditions.

Ld. PP in-charge raises objection and leaves the matter to the discretion of the court.

Having heard both sides and considering the period of long detention of the accused person and the facts and circumstances of this case, the prayer for bail of the accused person is allowed subject to condition. The accused person namely **Gopal Karmakar** may be enlarged on bail on furnishing a bond of Rs. 5,000/- with two registered sureties of Rs. 2,500/- each subject to satisfaction of Ld. ACJM, Bangaon and on condition to remain present in court on each and every date fixed.

If on bail to **14.05.2024** for appearance of accused person and evidence.

Let a copy of this order be sent to Ld. ACJM, Bangaon for information and compliance.
