At this stage it is submitted by the accused Bapi Biswas @ Sajal Mondal in open court that he is not in position to appoint any advocate to defend his case and prays for appointment of defence counsel from the legal aid panel.

Heard the submission of the accused, perused the petition filed by the ld. Defence counsel. Both prayers are allowed.

Write to the Chairman, Sub Divisional Legal Services Committee, Bangaon, for appointment of a defence lawyer for the accused namely **Bapi Biswas @ Sajal Mondal** by the next date fixed as the accused is in custody since long.

The Chairman, Sub Divisional Legal Services Committee, Bangaon, is requested to do the needful in this regard by the next date fixed.

Fix **01.12.2022** for appointment of defence counsel for accused Bapi Biswas @ Sajal Mondal and production of the accused person and appointment of P.P. in-charge.
