Heard both sides. The ld PP raises no objection.

Perused the petition and the case record and heard the ld advocate. In this case charge sheet has been submitted on 30.11.2022 after full investigation by the police. Therefore, one month has already elapsed after submission of charge sheet and it can be safely presumed that the aforesaid seized article is not required by the I/O for the purpose of investigation. There is no endorsement in the charge sheet by the I/O to the effect that the seized is required to be kept in the custody of the I/O for any purpose.

Hence, after due consideration of facts and circumstances in this matter it is my considered view that there is no impediment in allowing the instant petition. As such the instant petition is considered and allowed for ends of justice. Considering the materials in the case record the seized article Oppo Mobile Phone as per the seizure list dated 28.10.2022 be returned to the petitioner on furnishing a jimma bond of Rs. 15,000/- on condition that the said seized article shall be produced before this court as and when required at his own risk.

The I/O in this case namely, P.S.I. Dipak Kumar Saha, Swarupnagar P.S. is hereby directed to release and return the seized article of the following description :- one Oppo Mobile Phone, to the accused Nazima Khan. The I/O is also directed to prepare relevant panchnama and to hand over the seized Oppo mobile phone to the petitioner as per the seizure list dated 28.10.2022.

Accused Nazima Khan files jimma bond of Rs.15,000/-. Let the same be kept with the record.
