JUDGEMENT

(Delivered on this 16th day of November, 2019)

1. Today the accused namely, **Rajesh Samsun Dinkar** has contended before the Court that he voluntarily plead guilty for the offence punishable under Section 283 of Indian Penal Code. In view of submission of accused plea of the accused came to be recorded. It is satisfied that the plea is voluntary and therefore accepted.

2. Considering the age, antecedent of the accused and in view of nature of the offence, the following punishment would be commensurate in the circumstances of the case. Hence, the order.

ORDER

1. The accused namely, **Rajesh Samsun Dinkar** is convicted under Section 252 of the Code of Criminal Procedure for the offence punishable under Section 283 of Indian Penal Code. He is sentenced to pay fine of ₹ 200/- (Rs. Two Hundred only), in default to suffer simple imprisonment for 3 (three) days.
2. Judgment pronounced in open Court.
3. Copy of order be given to accused free of Cost.
