Hence, fine of Rs.200/- needs to be imposed on accused for ends of justice. In this view of matter I proceed to pass following order.

1.	Accused is convicted U/s 252 of Code of Criminal Procedure for the offence punishable U/s 283 of I.P.C. and sentenced to pay fine of Rs. 200/- (In words Rs. Two hundred), in default to suffer simple imprisonment for the period of 02 days.
