CHARGES WITH ONE HEADS
[No. XXVIII (II), SCHEDULE V, ACT, 1808]
[Sections 221,222, 223, Code of Criminal Procedure]

hereby charge you namely
as follows :

1.Subrata Mondal.
2.Shibpada Mondal.
3.Lila Mondal.
4.Supriya Biswas.
5.Rampada Biswas.

Firstly- That you Subrata Mondal being the husband of Anamika Mondal and rest you being her in laws, since her marriage, at her matrimonial home, in furtherance of common intention of all subjected her to cruelty both physically and mentally and that you thereby committed an offence punishable u/s **498A/34 of IPC** and within the cognizance of this court.

Secondly- That you Subrata Mondal being the husband of Anamika Mondal and rest you being her in laws, since her marriage, at her matrimonial home, in furtherance of common intention of all, and you being entrusted with stridhan articles of Anamika Mondal, converted the same to your own use and that you thereby committed an offence punishable u/s **406/34 of IPC** and within the cognizance of this court.

Thirdly- That you on 12-03-2020, at about 7 AM, at her matrimonial home, in furtherance of common intention of all, assaulted her and tried to kill her by pressing her mouth with pillow with such intention, knowledge that under such circumstances that by that act you had caused the death of Anamika Mondal you would have been guilty of murder and on 25-07-2020 at about 6 PM, at her parental home, assaulted her mother Ashalata Sarkar with intend to kill her under such circumstances that by that act you had caused the death of Ashalata Sarkar you would have been guilty of murder that you thereby committed an offence punishable u/s **307/34 of IPC** and within the cognizance of this court.

Fourthly- That you Subrata Mondal being the husband of Anamika Mondal and rest you being her in laws, since her marriage, at her matrimonial home, in furtherance of common intention of all, committed criminal intimidation by threatening Anamika Mondal with injury to her person and that you thereby committed an offence punishable u/s **506/34 of IPC** and within the cognizance of this court.

Fifthly- That you Subrata Mondal being the husband of Anamika Mondal and rest you being her in laws, since her marriage, at her matrimonial home, in furtherance of common intention of all, abetted giving and taking dowry from Anamika Mondal and that you thereby committed an offence punishable u/s **4 of D.P.Act** and within the cognizance of this court.

That the content of the said charges is read over and explained to them to which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

All the five accused persons on C.B. are present by filing hazira. they are taken into custody. Today is fixed for consideration of charge. Ld. PP-in-Charge is present.

Heard both sides.

Perused the case records, charge sheet and the documents filed.

Considered.

On perusal of the case records, charge sheet and the documents filed, this Court feels, there are sufficient materials for presuming, the accused persons have committed the offence punishable u/s **498A/406/307/506/34 of IPC and 4 of D.P.Act**. The substance of accusation of the offence is that the accused Subrata Mondal being the husband of Anamika Mondal and rest accused being her in laws, since her marriage, at her matrimonial home, in furtherance of common intention of all subjected her to cruelty both physically and mentally over the demand of dowry, valuable articles and on 12-03-2020, at about 7 AM, at her matrimonial home, they attempted to kill her by pressing her mouth with pillow and finally drove her out and on 25-07-2020 at about 6 PM, at her parental home they assaulted Anamika Mondal and her mother and threatened her with dire consequences. The substance of accusation of the offence punishable u/s **498A/406/307/506/34 of IPC and 4 of D.P.Act** is read over and explained to the accused persons to which they plead not guilty but claims to be tried. The charge so framed is also written in separate form and kept with the record. Thus the charge has been framed against the accused persons.
