Today is fixed for evidence of C.S.W 15 .

Accused person namely Siddhi Mondal is produced from J.C through V.C and he is taken into custody and remanded to J.C till next date.

Ld.Spl. P.P is present and files hazira for the State .

No witness turns up.

One petition has been filed on behalf of the accused in view of petition allowed along with Web copy of order of the Hon'ble Court ,Calcutta passed in C.R.M. (DB )No. 4386 of 2024 dt. 26.02.2025 supported by an affidavit thereto.

On perusal of web copy of order of the Hon'ble Court ,Calcutta passed in C.R.M. (DB )No. 4386 of 2024 dt. 26.02.2025 being supported by an affidavit filed on behalf of the accused person to that effect, it appears that their Lordships have been pleased to grant accused person /petitioner Siddhi Mondal , ' *on bail upon furnishing a bond of Rs.10,000/- (Rupees Ten Thousand only ) , with two sureties of like amount each , one of whom must be local , to the satisfaction of the learned Additional Chief Judicial Magistrate , Basirhat, North 24 Parganas ,subject to condition that the petitioner shall appear before the trial court on every date of hearing until further orders and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever*

*In the event, the petitioner fails to comply with the conditions as enshrined hereinbefore, it is open to the trial court to cancel the bail without further reference to this court'.*

Considering such circumstances prayer for bail is considered and allowed.

Accordingly, accused person namely ' *on bail upon furnishing a bond of Rs.10,000/- (Rupees Ten Thousand only ) , with two sureties of like amount each , one of whom must be local , to the satisfaction of the learned Additional Chief Judicial Magistrate , Basirhat, North 24 Parganas ,subject to condition that the petitioner shall appear before the trial court on every date of hearing until further orders and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever*

*In the event, the petitioner fails to comply with the conditions as enshrined hereinbefore, it is open to the trial court to cancel the bail without further reference to this court'.*

Accordingly, ld adv on record is directed to furnish the necessary bonds on behalf of accused person namely Siddhi Mondal as per order of the Hon'ble Court.

Certified copy of order of Hon'ble along with the copy of this order be sent to the Ld. *Additional Chief Judicial Magistrate , Basirhat, North 24 Parganas ,for information and necessary action.*
