CHARGES WITH TWO HEADS
[No. XXVIII (II), SCHEDULE V, ACT, 1808]
[Sections 221,222, 223, Code of Criminal Procedure]

at Basirhat, North 24 Parganas.

hereby charge you namely
as follows :

Accused named
Alamin Gazi, Abul Gazi and Sakila Bibi.

Firstly- That you Alamin Gazi being the husband of Serina Khatun and you rest accused being her in-laws, since her marriage, at her matrimonial home, specially on 10-11-2019 at about 2 PM, in furtherance of common intention of all, subjected her to cruelty both physically, mentally by demanding money, valuable articles, furniture and by beating her up, abetting her to commit suicide, driving her out from her matrimonial home and that you thereby committed an offence punishable u/s **498A/34** of IPC and within the cognizance of this court.

Secondly- That you, Alamin Gazi being the husband of Serina Khatun and you rest accused being her in-laws, in furtherance of common intention of all, since her marriage, specially on 10-11-2019 at about 2 PM, at her matrimonial home, were entrusted with the property which she received in her marriage and you converted the same to your own use and committed criminal breach of trust in respect of the said entrusted property and that you thereby committed an offence punishable u/s **406/34 of IPC** and within the cognizance of this court.

Thirdly – That you, Alamin Gazi being the husband of Serina Khatun and you rest accused being her in-laws, in furtherance of common intention of all, on 23-11-2019, at about 10 AM, at her paternal home, committed dowry death by causing death of Serina Khatun and that you thereby committed an offence punishable u/s **304B/34 of IPC** and within the cognizance of this court.

Fourthly –That on 23-11-2019, at about 10 AM, at her paternal home, Serina Khatun committed suicide and you, Alamin Gazi being the husband of Serina Khatun and you rest accused being her in-laws, in furtherance of common intention of all, abetted its commission by torturing her over demand of more dowry, misappropriating her property which she received in her marriage, driving her out from her matrimonial house and that you thereby committed an offence punishable u/s **306/34 of IPC** and within the cognizance of this court.

Fifthly –that you Alamin Gazi being the husband of Serina Khatun and you rest being her in-laws, since her marriage, at her matrimonial home, specially on 10-11-2019 at about 2 PM, in furtherance of common intention of all, abetted the taking dowry and demanded dowry and that you thereby committed an offence punishable u/s **4 of DP Act read with sec. 34 of IPC** and within the cognizance of this court.

That the content of the said charges is read over and explained to them to

which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

All the 3 accused persons on C.B. are present by filing hazira. They are taken into custody. Today is fixed for consideration of charge. Ld. PP-in-Charge is present.

Heard both sides.

Perused the case records, charge sheet and the documents filed.

Considered.

On perusal of the case records, charge sheet and the documents filed, this Court feels, there are sufficient materials for presuming, the accused persons have committed the offence punishable u/s **498A/406/304B in alternative sec. 306/34 of IPC & 4 of DP Act.** The substance of accusation of the offence is that the accused Alamin Gazi being the husband of Serina Khatun and the rest accused being her in-laws, since her marriage, at her matrimonial home, in furtherance of common intention of all, subjected her to cruelty both physically, mentally by demanding dowry, beating her up, abetting her to commit suicide, driving her out from her matrimonial house on 10.11.2019 at about 2PM and finally on 23-11-2019, at about 10 a.m., she committed suicide by consuming acid at her parental house and the accused abetted committing suicide in alternative caused dowry death of her. The substance of accusation of the offence punishable u/s **498A/406/304B in alternative sec. 306/34 of IPC & 4 of DP Act** is read over and explained to the accused persons to which they plead not guilty but claims to be tried. The charge so framed is also written in separate form and kept with the record. Thus the charge has been framed against the

accused persons.
