On perusal it appears to me that there are sufficient grounds for framing of charge against the accused persons namely, **Abu Chhiddik Molla** and **Abusadek @ Abusadak Molla** u/s 137(2)/140(3)/61(2) of BNS and for framing of charge against the accused person namely, **Abusadek @ Abusadak Molla** additionally u/s 65(1) of IPC and section 6 of POCSO Act.

**Secondly** – That both of you, on 16/03/2025 at about 7 a.m. (morning) at village Sankardaha under P.S. Nazat kidnapped (or abducted) the V.G. (a female minor date of birth 18/12/2010) with intent to cause the said V.G. to be secretly and wrongfully confined and both of you thereby committed an offence punishable under section **140 (3)** of B.N.S. and within the cognizance of this Court.

**Thirdly-** That both of you, on 16/03/2025 at about 7 a.m. (morning) at village Sankardaha under P.S. Nazat, agreed to do (or caused to be done an illegal act of kidnapping the minor V.G. ) and that the same act was done in pursuance of the agreement between you two persons and both of you thereby committed an offence punishable under section **61 (2)** of B.N.S. and within the cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused persons to which they pleaded not guilty by saying ‘Amra Nirdosh’ and claim to be tried.

(a female minor date of birth 18/12/2010) and thereafter committed penetrative sexual assault upon the minor V.G. repeatedly and hence committed an offence punishable under section **6** POCSO Act and within the cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused person to which he pleaded not guilty by saying 'Ami Nirdosh' and claim to be tried.
