Firstly- That you, Tanmay Barui being the husband of deceased Pallabi Barui and you Gour Mohan Barui, Kalpana Barui and Priyanka Barui being her inlaws, in furtherance of the common intention of all, since her marriage at her matrimonial home, subjected her to cruelty both physically and mentally and that you thereby committed an offence punishable u/s **498A/34 of IPC** and within the cognizance of this court.

Secondly- That you, Tanmay Barui being the husband of deceased Pallabi Barui and you Gour Mohan Barui, Kalpana Barui and Priyanka Barui being her inlaws, in furtherance of the common intention of all, since her marriage at her matrimonial home, being entrusted with her stridhan property, mentioned in the complaint, converted the same to your own use and that you thereby committed an offence punishable u/s **406/34 of IPC** and within the cognizance of this court.

Thirdly- That you, Tanmay Barui being the husband of deceased Pallabi Barui and you Gour Mohan Barui, Kalpana Barui and Priyanka Barui being her inlaws, since her marriage at her matrimonial home, agreed with each other to subject her to cruelty and that the same act was done in pursuance of the agreement and that you thereby committed an offence punishable u/s **120B of IPC** and within the cognizance of this court.

That the contents of the said charges is read over and explained to them to which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

Firstly- That you, on 01.01.2023, in the night, at rented accommodation at Hangling Hanuman Temple, Ramchandra Building, P.S. Suryanagar, Bangalore, Pallabi Barui committed suicide and in furtherance of the common intention of all, **both of you** abetted its commission by instigating her to commit suicide and that you thereby committed an offence punishable u/s **306/34 of IPC** and within the cognizance of this court.

Secondly- That you **Tanmay Barui** on 01.01.2023, in the night, at rented accommodation at Hangling Hanuman Temple, Ramchandra Building, P.S. Suryanagar, Bangalore, did commit murder by intentionally, knowingly causing the death of Pallabi Barui and that you thereby committed an offence punishable u/s **302 of IPC** and within the cognizance of this court.

Thirdly- That you, on 01.01.2023, in the night, at rented accommodation at Hangling Hanuman Temple, Ramchandra Building, P.S. Suryanagar, Bangalore, agreed with each other to cause death of Pallabi Barui and that the same act was done in pursuance of the agreement and that you thereby committed an offence punishable u/s **120B of IPC** and within the cognizance of this court.

That the contents of the said charges is read over and explained to them to which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

All the accused persons are present. The record is taken up for framing of charge.

Perused the case record, charge sheet and the documents filed.

The substance of accusation of the offence is that Tanmay Barui being the husband of deceased Pallabi Barui and Gour Mohan Barui, Kalpana Barui and Priyanka Barui being her inlaws, in furtherance of the common intention of all, since her marriage at her matrimonial home, subjected her to cruelty both physically and mentally and misappropriated her stridhan property and on 01.01.2023, in the night, at rented accommodation at Hangling Hanuman Temple, Ramchandra Building, P.S. Suryanagar, Bangalore, Pallabi Barui committed suicide and in furtherance of the common intention of **both Tanmay Barui, Santana Barui** abetted its commission by instigating her to commit suicide or in alternative Tanmay Barui having hatched conspiracy with Santana Barui caused death of Pallabi Barui. On perusal of the case records, charge sheet and the documents filed, this Court feels, there are sufficient materials for presuming, the accused persons namely, **Tanmay Barui, Gour Mohan Barui, Kalpana Barui, Priyanka Barui** have committed the offence punishable u/s **498A/406/120B/34 of IPC.** and the accused **Tanmay Barui, Santana Barui** have committed the offence punishable **u/s 306/34/120B** of IPC and in alternative the accused Tanmay Barui has committed the offence punishable **u/s 302/120B of IPC.** The substance of accusation of the offence punishable u/s **498A/406/306 in alternative 302/120B/34 of IPC** is read over and explained to the accused persons to which they plead not guilty but claim to be tried. The charge so framed is also written in separate form and kept with the record. Thus the charge has been framed against the accused persons.
