hereby charge you namely

as follows : Accused named

**1. Abdul Hamid @ Hamid Molla, 2. Latif Molla, 3) Mamtaj Bibi, 4)
Samiran Molla, 5) Mamhuda Bibi, 6) Khadija Molla,**

Firstly- That you **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, since her marriage, at her matrimonial house at different point of time, specifically on 01.02.2020, at 10 AM in the morning, in furtherance of common intention of all, subjected her to cruelty both physically and mentally over demand of money, other articles and that you thereby committed an offence punishable u/s **498A/34 of IPC** and within the cognizance of this court.

Secondly- That you **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, since after her marriage, at her matrimonial house at different point of time, specifically on 01.02.2020, at 10 AM in the morning, in furtherance of common intention of all, being entrusted with property of Tama Bibi which she got in her marriage, converted the same to your own use and that you thereby committed an offence punishable u/s **406/34 of IPC** and within the cognizance of this court.

Thirdly- That you **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, on 01.02.2020, at 10 AM in the morning, at her matrimonial house, in furtherance of common intention of all, caused the death of Tama Bibi by strangulation within seven years of her marriage and soon before her death she was subjected to cruelty or harassment by you in connection with the demand of dowry and that you thereby committed an offence punishable u/s **304B/34 of IPC** and within the cognizance of this court.

Fourth- That you **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, on 01.02.2020, at 10 AM in the morning, at her matrimonial house, in furtherance of common intention of all, did commit murder intentionally and knowingly causing death of Tama Bibi and that you thereby committed an offence punishable u/s **302/34 of IPC** and within the cognizance of this court.

Fifth –that you, on 01.02.2020, around 10 a.m. in the morning, in the

matrimonial house of Tama Bibi, agreed with each other to cause dowry death or in alternative murder of Tama Bibi and finally caused death of Tama Bibi by strangulation and besides the above said agreement you did some acts in pursuance of the said agreement to commit the offence of dowry death or in alternative murder of Tama Bibi punishable with death or imprisonment for life and that you thereby committed an offence punishable u/s **120B of IPC** and within the cognizance of this court.

Sixth- That you **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, since after her marriage, at her matrimonial house at different point of time, specifically on 01.02.2020, at 10 AM in the morning, in furtherance of common intention of all, demanded from Tama Bibi and her father, dowry consisting of cash, other articles and that you thereby committed an offence punishable **u/s 4 of DP Act / 34 of IPC** and within the cognizance of this court.

That the contents of the said charges is read over and explained to them to which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

All the six accused persons are present by filing hazira. Ld. P.P. in charge files hazira. Today is fixed for consideration of charge.

The record is taken up for framing of charge. Having heard both sides and on perusal of the case records, charge sheet and the documents filed, this Court feels, there are sufficient materials for presuming, the accused persons have committed the offence punishable u/s **498A/406/304B in alternative 302/120B/34 of IPC and sec. 4 D.P. Act/34 of IPC.** The substance of accusation of the offence is that the accused **Abdul Hamid @ Hamid Molla** being the husband and rest accused being inlaws of Tama Bibi, since her marriage, at her matrimonial house at different point of time, specifically on 01.02.2020, at 10 AM in the morning, at her matrimonial house, in furtherance of common intention of all, subjected Tama Bibi to cruelty both physically and mentally over demand of dowry including cash, costly articles and misappropriated her property which she got in her marriage and finally caused the death of Tama Bibi by strangulation within seven years of her marriage and soon before her death she was subjected to cruelty or harassment by accused in connection with the demand of dowry. The substance of accusation of the offence punishable u/s **498A/406/304B in alternative 302/120B/34 of IPC and sec. 4 D.P. Act/34 of IPC** is read over and explained to the accused persons to which they plead not guilty but claim to be tried. The charge so framed is also written in separate form and kept with the record. Thus the charge has been framed against the accused persons.
