**Hereby charge you Utpal Mondal @ Kelo son of Tarak Mondal village
Sashina, P.S. Basirhat
as follows :-**

Firstly : - That you on and that on 10.10.2017 at 21.00 hours at the dwelling house of Sona Adhikary, Palpara, Basirhat you committed rape on Sona Adhikary daughter of Late Ganesh Adhikary you forcibly raped against her will with an assurance of marry her you thereby committed an offence punishable under section **376** of the Indian Penal Code and within my cognizance.

Secondly, that you on and that on 10.10.2017 at 21.00 hours at the dwelling house of Sona Adhikary, Palpara, Basirhat you committed rape on Sona Adhikary daughter of Late Ganesh Adhikary you forcibly raped against her will with an assurance of marry her and subsequently deny and cheated her in marry her and that you thereby committed an offence punishable under section **417** of the Indian Penal Code and within my cognizance .

And I hereby direct that you be tried by the said Court on the said charge.

The charge framed is read over and explained to the accused person in Bengali to which he pleaded not guilty and claimed to be tried.
