Petition has been filed by the I.O. praying for seven (07) days police custody of the accused Dipankar Munda on the ground of investigation as stated therein. The application is duly forwarded by the O.C., Matia P.S., C.I., Swarupnagar and SDPO, Baduria.

Heard ld. Spl. P.P as well as ld. advocate for the accused.

On perusal of C.D and the police remand prayer as also the nature and circumstances of this case and for the purpose of effective investigation, to interrogate him in prolonged session, to unearth the actual truth behind this crime, to proper fixation of place of occurrence, to seize the wearing apparel of the accused person and to collect more material evidences facilitated investigation in this case, I am of the view that four (04) days police remand prayer is sufficient for the purpose.

Accordingly, I.O's prayer for taking accused Dipankar Munda police remand is allowed but only for 04 (four) days commencing from this day i.e. 07.07.2025 with a direction to produce the accused sharp at 10.30 a.m. on 11.07.2025.

The I.O is directed to comply all the guidelines of our Hon'ble Apex Court in this behalf strictly and not to manhandle the accused in any manner during the said period as also to provide all possible medical assistance to the accused during such period .

To 11.07.2025 for production from police remand and C.D.
