1. Palash Mondal @ Raja

Firstly- That you, on 10/4/2021 kidnapped the minor V.G. from the lawful guardianship of the maternal uncle of the V.G. and thereby committed an offence punishable under section **363** of **I.P.C.** and within the cognizance of this Court.

Secondly – That you, on 10/4/2021 kidnapped (or abducted) the V.G. with intent to cause the said V.G. to be secretly and wrongfully confined and thereby committed an offence punishable under section **365** of **I.P.C.** and within the cognizance of this Court.

Thirdly- That you on 10/04/2021 wrongfully confined the V.G. of this case at your house situated at village – Salua under P.S. Baduria till 25/04/2021 and that you thereby committed an offence punishable under section **342** of I.P.C. and within my cognizance.

Fourthly – That you, on 10/04/2021 and thereafter on several occasions committed rape upon the V.G. of this case (a female minor aged 16 years) at your house situated at village – Salua under P.S. Baduria and you thereby committed an offence punishable under section **376(2)(n)** of I.P.C. and within the cognizance of this Court.

Fifthly – that you, on 10/04/2021 at your house situated at village – Salua under P.S. Baduria committed criminal intimidation by threatening the V.G. with injury to her person (or reputation, or property) with intent to cause alarm to the V.G. and you thereby committed an offence punishable under section **506** of I.P.C. and within the cognizance of this Court.

Sixthly,- That you, on 10/04/2021 and on repeated occasions thereafter committed penetrative sexual assault on the minor V.G. aged 16 years and hence committed an offence of aggravated penetrative sexual assault punishable under section **6** POCSO Act and within the cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused person to which he pleaded not guilty by saying ‘Ami Nirdosh’ and claim to be tried.
