(a female minor aged 16+ years) with intent to cause the said V.G. to be secretly and wrongfully confined and thereby committed an offence punishable under section **365** I.P.C. and within the cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused person to which he pleaded not guilty by saying 'Amra Nirdosh' and claim to be tried.

(a female aged 16+ years being a child) and thereby committed penetrative sexual assault on the minor V.G. and hence committed an offence punishable under section **4** POCSO Act.

Forida Khatun** u/s 363/365 IPC and **additionally against accused Rahul Naskar** u/s 376 of IPC and section 4 of POCSO Act.

Accordingly charge is framed against all the accused persons u/s 363/365 IPC and additionally charge is framed against the accused person namely, **Rahul Naskar** u/s 376 IPC and section 4 of POCSO Act in separate sheets of paper in prescribed form.

The contents of charge are read over and explained to accused persons in Bengali, to which they pleaded not guilty by saying “ amra nirdosh” and claims to be tried.
