Accordingly charge is framed against the accused person u/s- u/s 354D/506/509 of I.P.C. and section 66C/66E/67A of Information Technology Act and section 12 of POCSO Act in separate sheet of paper in prescribed form.

The contents of charge are read over and explained to accused persons in Bengali, to which they plead not guilty by saying “amra nirdosh” and claim to be tried.

**Firstly-** That you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar followed the V.G. of 17 years age to foster personal interaction despite a clear indication of disinterest by the V.G. and you thereby committed an offence punishable under section **354D** of I.P.C. and within the cognizance of this Court.

**Secondly –** That you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar committed criminal intimidation by threatening the V.G. (age 17 years) with injury to her person (or reputation, or property) with intent to cause alarm to the said V.G. and you thereby committed an offence punishable under section **506** of I.P.C. and within the cognizance of this Court.

**Thirdly-** That you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar intending to insult the modesty of the V.G., uttered the words, intending that the same shall be heard (or seen) by the said V.G. of 17 years age and you thereby committed an offence punishable under section **509** of I.P.C. and within the cognizance of this Court.

**Fourthly-** that you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar fraudulently (or dishonestly) made use of the electronic signature (password) of the minor V.G. of her social media account and used the same to post obscene videos of the V.G. in her profile and thereby committed offence punishable under section **66C of Information Technology Act** and within cognizance of this Court.

**Fifthly-** that you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar published or transmitted the photos/videos to the minor V.G. and to nephew of the defacto-complainant and also published the same on social media without the minor V.G.'s consent under circumstances violating the privacy of the minor V.G. and hence committed offence punishable under section **66E of Information Technology Act** and within cognizance of this Court.

**Sixthly -** that you, prior to lodging the complaint i.e. 12/12/2022 at village Balki under P.S. Swarupnagar published (or transmitted) in the electronic form material which contained nude videos of the V.G. which were sexually explicit and thereby committed offence punishable under section **67A of Information Technology Act** and within cognizance of this Court.

**Seventhly, -** That you, prior to lodging the complaint i.e. 12/12/2022 repeatedly/ constantly followed/watched/contacted the minor V.G. of this case through phone/ mobile/otherwise and also threatened to use the V.G.'s objectionable pictures had committed sexual harassment upon the V.G. of 17 years age and hence committed sexual harassment punishable under section **12** POCSO Act and within the cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused person to which he pleaded not guilty by saying 'Ami Nirdosh' and claim to be tried.
