Firstly, that all of you, in furtherance of common intention of all, on 24/10/2021 at about 7:30 PM (evening) at the house of the defacto complainant at village Chanralkhali under Hingalganj P.S. committed house trespass by entering into the dwelling house of the defacto-complainant and that you thereby committed an offence punishable under section 448 r/w section 34 of the Indian Penal Code and within the cognizance of this Court.

Secondly, that all of you, in furtherance of your common intention, on above date and place assaulted the minor son of the defacto-complainant and her minor daughter [the V.G., 17 years of age] and wrongfully caused grievous hurt to them and that all of you thereby committed an offence punishable under section 325 read with section 34 of the Indian Penal Code and within the cognizance of this Court.

Thirdly- That all of you, in furtherance of your common intention, on 24/10/2021 at about 7:30 PM (evening) at the house of the defacto complainant at village Chanralkhali under Hingalganj P.S. assaulted the minor daughter of the defacto-complainant i.e. the V.G. and tore her wearing apparels with intention to disrobe her and compelling her to be naked and you thereby committed an offence punishable under section 354B I.P.C read with section 34 of the Indian Penal Code and within the cognizance of this Court.

Fourthly – that all of you, on 24/10/2021 at about 7:30 PM (evening) at village Chanralkhali under Hingalganj P.S. committed criminal intimidation by threatening the V.G. with injury to her person (or reputation, or property) with intent to cause alarm to the V.G. and you thereby committed an offence punishable under section 506 of I.P.C. and within the cognizance of this Court.

Fifthly, -- That all of you, on 24/10/2021 at about 7:30 PM (evening) at the house of the defacto complainant at village Chanralkhali under Hingalganj P.S. touched all over the body and private part of the minor V.G. of this case with sexual intent and committed sexual assault upon the V.G. who is aged 17+ years and hence committed offence punishable under section 8 POCSO Act and within cognizance of this Court.

And I hereby direct that you be tried by the said court on the said charges.

Charges are read over and explained to the accused persons to which they pleaded not guilty by saying ‘Amra Nirdosh’ and claim to be tried.
