Sahidul Gazi Firstly,that you, on 06.05.2022 at 8 p.m at village Kalinagar, P.S Nazat, Dist North 24-Parganas ,in furtherance of common intention , wrongfully restrained of victim girl and that you thereby committed an offence punishable under Section 341/34 of the Indian Penal Code, and within ⁽⁴⁾ the cognizance of this Court.

Secondly,that you, on06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in a house near the house of elder daughter of the de facto complainant in furtherance of common intention , dragged and voluntarily caused hurt to the victim girl **and that you thereby committed an offence punishable under section 323/34 of Indian Penal Code** and within⁽⁴⁾ **the cognizance of this Court.**

Thirdly, that you, on06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in furtherance of common intention , voluntarily caused grievous hurt to the victim girl , her father, elder sister and brother in law (jamai) and that you thereby committed an offence punishable under **Section 325/34** of Indian Penal Code, and within⁽⁴⁾ the cognizance of this Court.

Fourthly, that you, on 06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in furtherance of common intention ,voluntarily caused hurt rampantly to victim girl her father, elder sister and brother in law (jamai) with such intention (or knowledge) and under such circumstances that if by that act you have caused the death of said victim girl ,her father, elder sister and brother in law (jamai) , you would have been guilty of murder (and that you caused hurt to the said victim girl , by the said act) and that you thereby committed an offence punishable under **Section 307/34** of the Indian Penal Code, and within⁽⁴⁾ the cognizance of this court.

Fifthly, that you, on 06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in furtherance of common intention , used criminal force to the V.G and her elder sister, intending to outrage their modesty , and that you thereby committed an offence punishable under **Section 354/34** of Indian Penal Code, and within⁽⁴⁾ the cognizance of this Court.

Sixthly,that you, that you, on 06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in furtherance of common intention , abused the the V.G and her elder sister , in filthy language knowing it to be likely that you would thereby insult the modesty of a woman and that you thereby committed an offence punishable under **Section 509/34** of Indian Penal Code, and within⁽⁴⁾ the cognizance of this Special court.

Seventhly, that you, that you, on 06.05.2022 at 8 p.m and thereafter at village Kalinagar, P.S Nazat, Dist North 24-Parganas , in furtherance of common intention , committed sexual assault upon the minor victim girl and that you thereby committed an offence punishable under **Section 8 of Protection of Children From Sexual Offences Act (POCSO)**, and within⁽⁴⁾ the cognizance of this Special Court.

5) In case tried by Magistrates omit “by the said Court”

And I do hereby direct that you be tried ⁽⁵⁾ by this Court on the said Charge. The contents of charge is read over and explained to the accused persons in Bengali to which they plead not guilty and claim to be tried.
