C H A R G E

As follows,

That, you accused No.1 to 4 on 29/10/2018 at about 06.00 p.m., Vasai Fata, Hari Masjid, Sai Ganesh Mobile Care Store, Vasai East, Tal. Vasai, Dist. Palghar, either individually or in furtherance of your common intention, voluntarily caused hurt to informant and victim by means of broken tile and stone and thereby committed an offence punishable under section 324 read with section 34 of the Indian Penal Code and within my cognizance.

- 2) That, you accused No.1 to 4 on the above said date, time and place, either individually or in furtherance of your common

intention, voluntarily caused hurt to informant and victim by means of fist and blows and thereby committed an offence punishable under section 323 read with section 34 of the Indian Penal Code and within my cognizance.

3) That, you accused No.1 to 4 on the above said date, time and place, either individually or in furtherance of your common intention, insulted and thereby gave provocation to the informant intending that such provocation would cause to him to break the public peace and that you thereby committed an offence punishable under section 504 read with section 34 of the Indian Penal Code and within my cognizance.

4) That you accused, on the above said date, time and place, committed criminal intimidation by threatening informant and thereby committed an offence punishable under section 506 read with 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by me on the said charge.
