Firstly- That you, on 03-07-2025 at about 08:30 Hrs, at BP No. 13/4R-07, BOP Tarali-1, crossed the IB and entered into India without any valid passport or travel documents and that you thereby committed an offence punishable u/s **14A(b) of the Foreigners Act** and within the cognizance of this court.

Secondly –that you, on the same date, time and place you failed to produce for inspection your passport or travel document to cross IB and that you thereby committed an offence punishable u/s **12 of the PP Act** and within the cognizance of this court.

That the content of the said charges is read over and explained to them to which they plead not guilty but claim to be tried.

And, hereby direct that you be tried by the said Court on the said charges.

The substance of accusation of the offence is that **on 03-07-2025 at about 08:30 Hrs, at BP No. 13/4R-07, BOP Tarali-1**, the accused person crossed the IB and entered into India without any valid passport or travel documents. The substance of accusation of the offence punishable u/s **14A(b) of the Foreigners Act, 12 of the PP Act** is read over and explained to the accused person to which he pleads not guilty but claims to be tried. The charge so framed is also written in separate form and kept with the record. Thus the charge has been framed against the accused person.
