CHARGES WITH TWO HEADS
[No. XXVIII (II), SCHEDULE V, ACT, 1808]
[Sections 221,222, 223, Code of Criminal Procedure]

hereby charge you namely
as follows :

Accused named
Baby Begum.

Firstly- That you, on 21-09-2023, at about 14:00 hrs, at OP 17, BOP Tarali 1, were trying to cross the IB from India to BD side without any valid passport or travel documents and that you thereby committed an offence punishable u/s **14A(b) of the Foreigners Act** and within the cognizance of this court.

Secondly –that you, on the same date, time and place you failed to produce for inspection your passport or travel document to enter into India and that you thereby committed an offence punishable u/s **12 of the PP Act** and within the cognizance of this court.

That the content of the said charges is read over and explained to her to which she pleads guilty by saying “ami doshi”.

And, hereby direct that you be tried by the said Court on the said charges.

Accused Baby Begum is produced from J/C physically. Today is fixed for production, appearance and consideration of charge.

The accused person namely, Baby Begum has filed a petition for pleading guilty.

Heard the Ld. Advocate for the accused.

Perused the case records, charge sheet and the documents filed.

It is alleged that **on 21-09-2023, at about 14:00 hrs, at OP 17, BOP Tarali 1**, BSF party apprehended the accused Baby Begum who was illegally trying to cross the IB from India to BD and on being asked, she failed to produce any valid document or travel document to enter into India.

On perusal of the case records, charge sheet and the documents filed, this Court feels, there are sufficient materials for presuming, the accused Baby Begum has committed the offence punishable under section 14A(b) of F. Act and 12 of PP Act. The substance of accusation of the offence punishable under section 14A(b) of F. Act and 12 of PP Act. is read over and explained to her to which she pleads guilty by saying “ami doshi”. The plea of guilty appears to be voluntarily made and the same is thus accepted. Accordingly, the accused named Baby Begum is convicted u/s 229 of Cr.P.C.

The accused person Baby Begum stated that she is very poor person and she was brought in this country by some unscrupulous persons on the pretext of giving her job; however she prays mercy. In this facts and situation of the case, this Court finds it appropriate to pass the minimum sentence and impose minimum fine prescribed in sec. 14A(b) of Foreigners Act and 12 of PP Act against the accused. Accordingly, the accused named Baby Begum is convicted u/s 229 of Cr.P.C for committing the offence u/s 14A(b) of Foreigners Act and 12 of PP Act on her guilty plea and sentenced to suffer rigorous imprisonment for a term of 02(two) years only and to pay fine of Rs. 10,000/-(ten thousand) only failing which she is to suffer S.I. for 01(one) month only for committing the offence u/s 14A(b) of Foreigners Act.

She is also sentenced to pay fine of Rs. 1000/-(one thousand) only for committing the offence u/s 12 of P.P. Act failing which she is to suffer S.I. for 05(five) days only.

The period of detention already undergone by the accused is to be set off against the sentence of imprisonment in view of sec. 428 of Cr.P.C.

Since the convict, Baby Begum is foreign national she will be deported back to her home country in accordance with procedure laid down in law on completion of the sentence.

Let the seized currency be forfeited to the state and other seized articles be destroyed according to law. Thus the case is disposed off.
