COMMITMENT ORDER

The above named accused has been sent by the Station House Officer, Police station, Dasuya for commission of offence under sections 379-B of the Indian Penal Code, 1860 (hereinafter referred to as IPC for brevity).

2. Briefly stated the facts of the present case are that the instant case was got registered by ASI Daljit Singh on the allegations that he along with HC Harbhajan Singh No. 989, PHG Ved Parkash No. 26076 were on paroling on private vehicles and were present at T Point Hajipur Chownk Dasuya and then a secret information was received that on 16-08-2021 at about 1-30 PM Kirandeep Kaur wife of Jaswinder Singh resident of Sibbo Chak, PS Hajipur was going to Army Canteen Unchi Bassi on her Scooty and when she reached just ahead of Lamin Bridge

Unchi Bassi side, one motor cycle make FZ colour Black Green bearing No. PB07AP-1411 came from behind upon which two Hindu gentlemen were sitting having aged about 26/27 years and whose names later on came out to be Sahil Kumar son of Balvir Kumar resident of Ram Nagar Colony, Mukerian Distt. Hoshiarpur and the name of the pillion rider was Saahil Masih resident of Kainthan Mohalla Dasuya. Then the pillion rider shown some Datar Type thing to Kirandeep Kaur and due to which Kirandeep Kaur reduced the speed of her Scooty. Then the pillion rider snatched the ear ring of Kirandeep Kaur and ran away towards Dasuya side. The information was reliable and on the basis of which the ruka was sent to the police station and the instant case was registered against the accused. Thereafter, when the investigating officer was present at T-Point Hajipur Chownk Dasuya, a secret information was received that on 16-8-2019 the persons who have snatched the ear ring of a women, and out of them one person namely Sahil Kumar is coming from the Mukerian side and if a Naka is held he can be apprehended. Upon which a Naka was held and the accused Sahil Kumar came on a motor cycle make FZ from Dasuya side and he was apprehended by the police party. On inquiry, he told his name as Sahil Kumar and the motor cycle number was PB-07 AP-1411. During investigation the accused Sahil Kumar confessed his guilt that on 16-8-2018 at about 1-30 PM he along with one Sahil Masih have snatched the ear ring of a lady who was on her scooty. Thereafter, during investigation, the investigating officer got recovered the ear ring and Datar on the disclosure statement of the accused.

3. On the basis of these allegations the above noted case against the accused was registered. The accused was arrested in the instant case. As per the disclosure statements of the accused the stolen articles have already been recovered from the accused.

4. After completion of the necessary formalities, challan against the accused was presented in the court. The accused was arrested. On presentation of the challan, the copies of the challan and other documents as relied upon by the prosecution were supplied to the accused free of costs.

5. I have heard the learned APP for the State, learned defence counsel and have gone through the file very carefully.

6. From the perusal of the file I find that a prima facie case for offence under sections 379-B of the Indian Penal Code appears to be made out against the accused. Offence under section 379-B of the Indian Penal Code is exclusively triable by the Court of Sessions. As such, this case is committed to the Court of Learned Sessions Judge, Hoshiarpur for trial for 29-11-2021. The accused is on bail and he has been directed to appear before the Learned Sessions Judge, Hoshiarpur on 29-11-2021 at 10 AM sharp. Ahlmad is directed to send the file complete in all respects to the court of Ld. Sessions Judge, Hoshiarpur well before the date fixed. Public Prosecutor be also notified.
