Commitment Order

1. The above named accused have been forwarded by S.H.O. Police Station City Batala to face trial for the commission of offences punishable under sections 379-B,411 of Indian Penal Code.
2. Briefly, the prosecution story is that on 5.2.2019 ASI Gurdev Singh alongwith other police party was present at Nehru Gate Batala in connection with patrol duty where complainant namely Pardeep Kumar son of Natha Ram resident of Gali No.2 Gandhi Camp Batala, P.S. Civil Lines, Batala, got recorded his statement to the effect that he works as salesman in the shop under the name and style of Babu Ram Telecom Loha Mandi, Batala. On 04.02.2019, he went out from shop to pass urine. At about 7.30 p.m, after passing urine, he was going towards his shop and when he reached in front of shop, then two boys came on Activa of white colour from Sabji Mandi side and snatched away his mobile phone make Oppo having Airtel Sim No. 84275-06015 from his right hand. From CCTV Camera footage, it came to know that names of snatchers are Lovedeep Singh and Surajpreet Singh, residents of Gobind Nagar, Kahnuwan Road, Batala.
3. On the basis of the statement of the complainant present FIR was registered. Investigation was ensued by ASI Gurdev Singh. Site plan of place of occurrence was prepared. On 5.2.2019, both the accused were arrested and as per their disclosure statements recovery of snatched mobile and Active vehicle was effected and same were

taken into police possession vide separate memo. Statement of witnesses were recorded. Thereafter, on completion of other formalities of investigation, challan against both the accused was presented in the court.

4. After appearance of accused before this Court, copies of challan and necessary documents as relied upon by prosecution were supplied to him, free of costs as envisaged under Section 207 of Code of Criminal Procedure, 1973.
5. I have heard the submissions made by learned APP for the State, learned counsel for accused and have gone through the judicial file carefully.
6. Accused have been charge-sheeted in the present case for commission of offence punishable under Sections 379-B, 411 IPC, out of which commission of offence punishable under Section **379-B IPC** is **exclusively triable by the Court of Sessions**. Accordingly, the present case is hereby committed to the Learned Court of Session.. Both the accused on bail in this case, are directed to appear before the Court of Learned Sessions Judge, Gurdaspur on **25.09.2020** at 10:00 A.M. sharp. Order of commitment be notified to the Public Prosecutor. Ahlmad of this Court is directed to send the record of the case along with documents and articles, if any, which are to be produced in evidence, complete in all respects, to the Court of Learned Sessions Judge, Gurdaspur, well before the date fixed.
