COMMITMENT ORDER

The present challan has been presented against the aforesaid
 accused persons by the Station House Officer, Police Station Sadar

Gurdaspur, to face trial for the commission of alleged offences punishable under Sections 307, 326, 324, 201, 148 149 of the Indian Penal Code.

2. In brief, the facts of the prosecution case are that present case was registered on the statement of complainant Ravinder Singh son of Kuldeep Singh, resident of Village Dostpur, Police Station Kalanaur, wherein he has stated that on 16.07.2022 at about 5.30 p.m, he along with his friend Gursahib Singh was present on the shop of Rana Mobile Repair, situated in Hardochhani Bazar. Gurdaspur. His friend Jugraj Singh also came out side the said shop. On seeing him, he also came out of the shop. At that time, Gurbax Singh son of Nanak Singh, resident of Sahoor Kalan, Lovepreet Singh alias Lovely son of Tara Singh, resident of Dostpur, Kirpal Singh alias Pala son of Avtar Singh, resident of Dostpur and Jatinder Singh alias Kaka son of Jaswant Singh, resident of Manepur, at present resident of Dostpur, came there in an Alto car. Two persons, namely, Harpreet Singh alias Happy son of Kulwant Singh, resident of Sahoor Kalan and Kuldeep Singh alias Kipa son of Gurmeet Singh, resident of Sahoor Kalan came there on a bullet motorcycle. Two unknown persons armed with sharp edged weapons and baseball bat came there on a motorcycle make Splendor. All of them alighted from their vehicles. Kirpal Singh alias Pala raised a lalkara that they be taught a lesson for raising dispute with them. Thereafter, the said persons attacked the complainant and his friends Gursahib Singh and Jugraj Singh with their weapons. Harpreet Singh alias Happy gave a blow with Dater on his right leg, thereafter Gurbax Singh son of Nanak Singh gave a blow on his right leg, Harpreet Singh alias Happy gave three more blows with Dater to the

complainant and when he raised his right hand to ward off attack, he sustained injuries on his right hand. Lovepreet Singh alias Lovely gave a blow with Dater on fingers no.2,3 4 of his left hand. Kuldeep Singh alias Kipa gave two blows with baseball bat on the right side of his mouth, left knee and thereafter Lovepreet Singh alias Lovely gave a blow with Dater on his right knee and Harpreet Singh alias Happy gave Dater blow on left side of his head with the intention to kill him. Thereafter, accused persons ran away from the spot along with their respective weapons. On the basis of said statement, FIR was registered against the accused persons. During investigation, accused persons were arrested. The weapon used in the commission of offence were recovered. The Investigating Officer collected medical evidence, recorded the statements of witnesses and rough site plan of place of occurrence was prepared. After completing other formalities of investigation, challan against accused persons was presented in the Court for trial.

3. Copies of challan etc. were supplied to the accused, free of costs, as envisaged under Section 207 of the Cr.P.C.

4. I have heard the submissions made by Ld. APP for State and Ld. defence counsel and have gone through the record.

5. From the perusal of the police report submitted under Section 173 Cr.P.C. and documents appended, it prima-facie appears that offences punishable under Sections 307, 326, 324, 323, 201, 148, 149 of IPC have been committed by accused persons, out of which, the offence under Section 307 of IPC is exclusively triable by the Ld. Court of Sessions. Therefore, the case is committed to the Court of Sessions for **08.05.2023**.

Accused Jatinder Singh in custody and prosecution is directed to produce him before the Court of Ld. Sessions Judge, Gurdaspur, on 08.05.2023 at **10.00 A.M. sharp**. Remaining accused persons are on bail and they are directed to appear before the Court of Learned Sessions Judge, Gurdaspur on the date fixed. The Ld. Public Prosecutor be notified regarding the commitment of this case, through Ld. A.P.P. present in the Court. The Additional Ahlmad of this Court is directed to send the file complete in all respects to the Court of Ld. Sessions Judge, at once well before the date fixed.
