COMMITMENT ORDER:-

1. Accused above named have been forwarded by the SHO of police station Sadar Patti, District Tarn Taran to face trial for offences punishable under Sections 307,34 of IPC and section 25/27/54/59 of Arms Act.

2. In brief the prosecution version is that on 30.11.2018, ASI Balwinder Singh was present at Police Post Gharyala. He received a telephonic call from Amandeep Hospital Amritsar regarding admission of Gurjot Singh son of Joginder Singh in hospital due to gunshot injury. Upon receiving information, ASI Balwinder Singh alongwith ASI Gurcharan Singh, HC Darshan Singh, C. Angrej Singh went to Amandeep Hospital and sought opinion of the concerned doctor regarding fitness of the injured Gurjot Singh. Concerned doctor declared the injured unfit to make statement. On 01.12.2018, ASI Balwinder Singh alongwith ASI Gurcharan Singh, HC Rajpal Singh, C. Angrej Singh went to Amandeep Hospital, Amritsar and sought opinion of the concerned doctor regarding fitness of the injured Gurjot Singh to make statement. Concerned doctor declared the injured fit to make statement. Thereafter, Gurjot Singh got recorded his statement to the effect that he has one elder sister namely Prabhjot Kaur. He has passed 10+2 in the year 2016 from Baba Lassi Ram Academy School, Talwandi Sobha Singh and thereafter has been pursuing IELTS at Matrix, Khem Karan Road Patti. On 29.11.2018 at about 5.05 P.M., he has gone to market at Gharyala to purchase some house hold articles on his motor cycle make Splendor bearing No. PB-46-AA-3931

and when he reached near Punjab National Bank, Gharyala, his friend Harpreet Singh son of Kashmir Singh resident of village Jand met him. They started talking to one another. When he was about to leave, Ravisher Singh, Milap Singh, Gurlal Singh, Gurjit Singh alongwith one unknown person came with weapons on one Swift Car. Said car was being driven by Milap Singh. Gurlal Singh raised Lalkara that Gurjot Singh be caught hold and be taught a lesson for helping Harpreet Singh. Upon this Ravisher Singh fired from his rifle DBBL .12 bore towards him and same hit on his right thigh. He fell down. Thereafter, Gurjit Singh fired from his rifle DBBL .12 bore towards him which hit on right leg. He started raising hue and cry. Blood started oozing out. On seeing the people gathering, all the accused fled away from the spot in their Swift car with their respective weapon. After listening to his cries, his friend Harpreet Singh, his uncle Resham Singh, Balwant Singh came to the spot and took him to Civil Hospital Patti after arranging the vehicle. There he was referred to Amandeep Hospital, Amritsar. Entire occurrence has been seen by Harpreet Singh, Resham Singh and Balwant Singh. The cause of occurrence was that accused were under misconception that he has been helping out his friend Harpreet Singh. Action be taken. On the basis of the statement, FIR under section 307,34 of IPC was registered. Site plan of the place of occurrence was prepared. Medical evidence was collected. Accused were arrested. Statements of witnesses were recorded. On completion of investigation challan was preapred and presented before this court on 15.05.2019.

3. On appearance of the accused in the Court, copies of

challan and necessary documents as relied upon by the prosecution were supplied to accused free of costs as required u/s 207 of Code of Criminal Procedure, 1973 (hereinafter referred to as **Cr.P.C.**).

4. Accused Gurjit Singh @ Jeeta, Milap Singh and Gurlal Singh have been arrested in the present case for alleged commission of offences punishable under Sections 307, 34 of IPC and section 25/27/54/59 of Arms Act. The offence punishable under Section 307 of IPC is exclusively triable by Learned Court of Sessions, so this case is committed to the Court of learned Sessions Judge, Tarn Taran for **08.08.2019**. Accused Milap Singh & Gurlal Singh on bail are directed to appear before the court of learned Sessions Judge, Tarn Taran on **08.08.2019** at 10.00 A.M. Sharp. Jail authorities are directed to produce accused Gurjit Singh @ Jeeta in the court of Learned Sessions Judge, Tarn Taran on 08.08.2019 at 10.00 A.M. Sharp, subject to provisions of Criminal Procedure Code, 1973 relating to bail and remand. Order of commitment be notified to the Public Prosecutor, Tarn Taran. Ahlmad of this Court is directed to send the file, complete in all respects, to the Court of learned Sessions Judge, Tarn Taran, well before the date fixed.
