1. Today is fixed for further consideration and files affidavit of service by the plaintiff.
2. The learned Advocate for the plaintiff appears and files hazira. However, no affidavit of service has been filed in compliance with the earlier order dated 23.03.2026.
3. The learned Advocate for the defendant appears and files hazira along with an application under Order VII Rule 10 of the Code of Civil Procedure, registered as I.A. No. 03/2026, and an application under Order VII Rule 11 of the Code of Civil Procedure, registered as I.A. No. 02/2026. Copies thereof have been served in open Court, as appears from the endorsements made thereon. The Learned Advocate also prays for acceptance of written statement as the same has been filed within 120 days.
4. Heard the learned Advocates for the respective parties. The learned Advocate for the plaintiff submits that he has no objection if the written statement filed by the defendant is accepted as the same has been filed well within the 120 day period from the date of receipt of summons. It is further submitted that the plaintiff intends to file written objections to the applications being IA nos 2 and 3 of 2026.

In view of the above, the IA 1 of 2026, being an application for acceptance of the written statement stands allowed.

5. No DCF has been filed by the defendant in terms of the order dated 16.04.2026.
6. The plaintiff is at liberty to file written objections to the application under Order VII Rule 10 of the Code of Civil Procedure, registered as I.A. No. 03/2026, and the application under Order VII Rule 11 of the Code of Civil Procedure, registered as I.A. No. 02/2026, on or before the next date of hearing. However, copies thereof shall be served upon the defendant at least fifteen (15) days prior to the next date of hearing.

The defendant shall be at liberty to file an affidavit-in-reply to such written objections, if any, on the next date of hearing, upon effecting advance service upon the other side.

7. Fix **13.08.2026** for hearing of the application under Order VII Rule 10 of the Code of Civil Procedure, registered as I.A. No. 03/2026 and for filing of affidavit of service by the plaintiff and DCF by the defendant.
8. The application under Order VII Rule 11 of the Code of Civil Procedure, registered as I.A. No. 02/2026, shall be taken up for consideration depending on the fate of IA 03/2026, after its disposal.
