They are taken into custody.</p> <p>Ld. Defence Counsel appearing on behalf of the accused persons files and moves a petition praying for bail on behalf of the said accused persons. Ld. Assistant Public Prosecutor raises formal objection.</p> <p>Heard the submission of Ld. Counsel for both the sides and considered the same. Perused the materials on record.</p> <p>On perusal of the case record, it transpired that the accused persons have been booked u/s 401A of Kolkata Municipal Corporation Act 1980. This court has no hesitation to hold that the accused person has been booked under Magistrate trial section and that the case record is mature for proceeding, given the fact that investigation is over.
