ORDER

The above named accused are sent up by the SHO of PS City I Mansa for trial under sections 148, 367, 323, 325, 149, 120-B IPC.

2. Brief facts of the case are that injured Kulwinder Singh @ Nikka son of Gurdeep Singh, resident of Near Triveni Mandir, Mansa suffered statement to the police that he has one elder brother Jaswinder Singh. On 30.06.2018 at about 5:30PM he and his mother Baljit Kaur were walking in Triveni Park, Mansa when Paramjit Singh @ Shama

armed with pistol, Kulwinder Singh @ Ziro armed with iron rod, Yadwinder Singh @ Yadu armed with Baseball, Gursaran Singh @ Gaggi armed with wooden Tamba, Maan armed with Baseball came in the park. Abovesaid Shama hit wooden Tamba on his ear and proclaimed that lift and took him to the field. Then two persons lifted him and bring him out of the park and two other persons who were already on a start motorcycle took him on that motorcycle. When they reached at Chakerian crossings, Mohna Singh, who was already there in a vehicle in which other unknown persons were also sitting, put him in side the vehicle and took him back side of N.M. College, Mansa and gave him beatings and thereafter they left the spot leaving him there with injuries. He was lifted from there by his friends and relatives and was admitted in Civil Hospital Mansa. The motive of this occurrence was that Paramjit Singh @ Shama is not having good relations with friends of complainant. On the basis of this statement FIR under sections 365, 323, 148, 149 IPC and 25 and 27 Arms Act was registered. Investigation was conducted. Accused were formally arrested and vehicles and weapons of offence were recovered from accused. Thereafter, on the basis of investigation offence under section 325 and 367 IPC was enhanced while offence under section 365 IPC and 25 and 27 Arms Act was deleted. Upon completion of investigation challan was presented against the accused under sections 148, 367, 325, 323, 149, 120-B IPC.

3. Copies of documents were supplied to the accused free of costs, as required under section 207 Cr. PC.

4. After hearing the Ld. APP for the State and the Ld. Defence counsel and going through the final report submitted by police, I am of the considered view that offence under section 367 IPC seems to be committed and it is exclusively triable by the court of Sessions. So, present case is committed to the Learned court of Sessions Judge, Mansa for 25.02.2021 for trial of the accused. Accused are directed to appear before the Learned court of Sessions Judge, Mansa on 25.02.2021 at 9.30 a.m. sharp. Commitment of this case be notified to Public Prosecutor as per the rules. Ahlmad is directed to prepare the Calendra and file be sent to the Court of Sessions well within time complete in all respects.
