The claim of the petitioner/s is that the petitioner/s sustained grievous injury/fatal in the accident occurred on **16-07-2021** by the Opponents' vehicle No. **RJ-07-GC-3512 & NL.01.L.7142** Hence this petition is filed for compensation.

This petition has been filed with the stamp of **Rs.2150/-**.

This Application is decided today on 11/07/2026 (National Lok-Adalat) before the Court of Shri **H.A.TRIVEDI Saheb**, A.D.J. & M.A.C.T.(AUXI.) Kheda at Nadiad. In presence of Shri **K.D.Chavda**-Ld.Advocate for the applicant and Shri A.C.Shah-Ld. Advocate for the opponents No.2, by Compromise pursis vide **Ex.20**.

~: O R D E R :~

1. Today, in National Lok-Adalat, the Ld. Advocate for the claimant/s has submitted compromise pursis at **Exh.20** and duly signed by the Ld. Advocate for the Claimant and Ld. Advocate for the Insurance Company. As per the aforesaid compromise pursis, the parties have settled the matter amicably and the Insurance Company has agreed to deposit the cheque amounting in **Rs.3,25,000/- (Rupees Three Lakh Twenty Five Thousand Only)** towards full and final settlement.
2. The above said amount of compensation shall be deposited in BANK OF BARODA MAIN BRANCH, NADIAD A/C.02900200000658 IFSC: BARB0NADIAD(Fifth letter is Zero) through RTGS/NEFT within 30 days from the date of this order.
3. After depositing the compensation amount, firstly to deduct interim compensation amount, if paid.
4. No amount for the deficit court fees stamp, be deducted as this compromise is made in National Lok-Adalat. Court Fees refund certificate be drawn in terms of applicable rules.
5. Rs.3,25,000/- by NEFT/RTGS to be paid to the applicant after due verification.
6. Both the parties agree to bear their own costs.
7. Award be drawn accordingly.
