Having heard the parties and Sh. Bhuvnesh Sharma, Ld. APP for the State, I find that the disposition worked out mutually by the parties is fair and just. The previous conviction report is already on record and as per previous conviction report accused has not been convicted in any other case.

The accused has paid Rs.25,000/- as compensation to complainant.

In view of the statement of the complainant, the offence U/s. 337 IPC stands compounded. **Accused stands acquitted for the said offence u/s 337 IPC.**

The accused has admitted his guilt and wants to avail the benefit of Chapter 21-A of Cr.P.C by Plea Bargaining, I am prima-facie satisfied that the charge against him is well-founded.

In view of plea of guilty made by the accused, he/she is convicted for the offence U/s 279 IPC.

ORDER ON SENTENCE

Heard on the point of sentence. Considering all the facts and circumstances of the case as well as conduct of the offender, the accused being first time offender, and the fact that complainant is adequately compensated, accused is hereby admonished for offences u/s 279 IPC.
