Said bail petition **U/s.437 Cr.PC, dt.19.05.2023 for accused accused Bishnupada Mahato @ Bishnu Mahato** is taken up for hearing.

At the time of hearing, Ld. Advocate for said accused person has prayed for bail for said accused and has submitted that this accused has been falsely implicated in this case and that this accused is in custody since **19.05.2023** and the investigation has proceeded much.

Ld. Spl. P.P has submitted that in the instant case the statements of the victim girl has been recorded U/s.164 Cr.P.C and that the investigation is in the initial stage.

On perusal of the materials in the C.D, it appears that the alleged offence is U/s.363,365,323,506,109 IPC & U/s.6, POCSO Act and that during investigation the statement of the victim girl has been recorded u/s.164 Cr.P.C. Perused the same. Also perused other materials in the C.D.

Accordingly, prayer for bail U/s.437 Cr.P.C for the accused Bishnupada Mahato @ Bishnu Mahato is hereby rejected at this stage.

Said accused is hereby remanded to J.C till 20.06.2023.

The bail petition U/s.437 Cr.PC, dt.19.05.2023 for accused accused Bishnupada Mahato @ Bishnu Mahato is accordingly disposed of.
