ORDER

This order shall decide the question of juvenility of Lakhwinder Singh son of Rajwinder Singh who was summoned as additional accused in this case upon application under Section 319 of the Cr.P.C. The incident in question is dated 26.03.2013 and when fresh charges were framed, aforesaid Lakhwinder Singh stated his age as 19 years as on 16.04.2015. Therefore the question of his juvenility arose and he was directed to lead evidence qua the same for the purpose of conducting enquiry. In the said enquiry, Lakhwinder Singh as AW1 tendered into evidence copy of his matriculation certificate as Ex.C1 in which his date of birth is mentioned as 15.02.1997. There is no contest to the aforesaid fact on behalf of the State. Therefore it comes out that on the date of alleged incident i.e. 26.03.2013, aforesaid Lakhwinder Singh was 16 years of age.

2. Therefore in view of the aforesaid, aforesaid Lakhwinder Singh son of Rajwinder Singh is hereby declared as juvenile. Papers relating to juvenile are ordered to be separated and copy of FIR, challan and order upon application under Section 319 of Cr.P.C, be sent to the

Juvenile Justice Board immediately for further proceedings. Juvenile is directed to appear before Juvenile Justice Board on 18.11.2015. The learned Public Prosecutor be informed regarding declaring of accused Lakhwinder Singh as juvenile through the learned APP for the State. Copy of this order be also sent to the Juvenile Justice Board, Mansa and the main file is adjourned to 08.01.2016 for prosecution evidence. Pws be also summoned for that date.
