Ld. Spl. P.P. Mr. N. L. Singhanian is present and has filed one petition dt.03.08.2023 submitted by S.I Lakshmi Kanta Pati of Barabazar P.S, I.O. of this case.

In said petition dt.03.08.2023 the I.O has stated inter alia that his prayer dt.28.07.2023 for Medico Legal Examination of the accused person namely Sandip Bouri at Deben Mahato Medical College and Hospital was allowed by this Ld. Court for the interest of investigation and that the date was fixed on 01.08.2023 with a direction upon the Surety of said accused to cooperate for holding Medico Legal Examination of the accused and that the I.O met with the Surety of the accused but the Surety did not cooperate with him and the accused is not available and the Medico Legal Examination could not be done.

Perused the materials in the case record. Heard Ld. Spl. P.P. Considered.

Ld. Spl. P.P has submitted that said accused **Sandip Bouri** is now on court bail and the Surety has failed to produce the accused and for this W.A may be issued against the accused.

The Sureties, namely, Madhusudan Gorai and Adhir Ch. Mahato has filed one joint petition today with a prayer for further time to produce said accused stating inter alia that said accused has gone to Gujarat for work and that at least 15 days time is required for his return.

Considering the entire facts and circumstances mentioned above, the prayer for time made by the Sureties of accused Sandip Bouri to produce said accused before the I.O of this case, is hereby allowed.

The Sureties of accused Sandip Bouri are to take necessary step for appearance of said accused before this court on 21.08.2023.
