Sk. Sakil @ Sk Sahid, S/o-Sk. Azhar of Vill.-Katinpar, Ward No.22 P.S.-Purulia(T), Dist.-Purulia.**

The I.O has submitted Redacted Copies of Formal F.I.R and Written complaint.

The Original Formal F.I.R and Written complaint are kept in the case record in sealed cover to maintain privacy of the V.G and the Redacted Copies of those documents are kept open in the case record.

02 accused persons namely, **1.Azad Ansari @ Pintu** and **2. Sk. Sakil @ Sk Sahid** have been brought under arrest and are produced before this court from the Purulia(T) P.S.

Seen the Forwarding Report, dt.13.08.2024, Accused Challan, dt.13.08.2024, 02 Memos of Arrest dt.13.08.2024 and 02 Inspection Memos dt.13.08.2024.

Let the documents be kept with the case record.

Said 02 accused persons are taken into custody.

L.S.I, Arpita Bhatta of Purulia(T) P.S, the I.O of this case has filed a petition through Ld. Spl. P.P, praying for necessary order for recording the statements of the victim girl and the defacto complainant (mother of V.G) U/s.183 BNSS.

The I.O is personally present in the Court today and has produced the victim girl (12 yrs.) and the defacto complainant (mother of V.G), accompanied by lady Constable, namely, Mousumi Mahato (LC/335) of Purulia(T) P.S.

The instant prayer of the I.O for recording the statements of the victim girl and the defacto complainant (mother of V.G), U/s.183 BNSS Act is hereby allowed for the interest of investigation.

Ld. J.M 4th Court Purulia is hereby requested to record the statements of the V.G and the defacto complainant (mother of V.G) U/s.183 BNSS following the procedure as per rules including Audio/Video recording.

Let the victim girl and the defacto complainant (mother of V.G) be produced before the Ld. J.M. 4th Court, Purulia, along with case record at once.

I would like to make it clear that the identity of the V.G should not be disclosed in any manner during the course of recording of their statements U/s. 183 BNSS as mandated in S.33 of the POCSO Act.

Ld. Advocate Mr. Manab Mukherjee, appointed by DLSA, Purulia, is present for said accused persons for providing free legal aid to said accused persons, as said accused persons have not appointed any advocate at his own cost.

I.O of this case, has filed a petition dt.13.08.2024 with a prayer for necessary order for Medico-Legal Examination of both the accused persons namely, **Azad Ansari @ Pintu** and **Sk. Sakil @ Sk Sahid** and for 08 days police remand of said 02 accused persons to identification and the arrest of other co-accused, recovery the weapon of offence & reconstruction of the crime for the interest of proper investigation of this case.

Both the accused person are taken into custody.

Let the petition of the I.O for Medico-Legal Examination and 08 days police remand of said 02 accused persons be considered on the next date.

To 14.08.2024 for production of both the accused from J.C and for hearing of the petition filed by the I.O for Medico-Legal Examination of the accused persons namely, Azad Ansari @ Pintu and Sk. Sakil @ Sk Sahid and for 08 days police remand of both the accused persons and for I.O's Report in Final Form.

Both the accused persons namely, **Azad Ansari @ Pintu** and **Sk. Sakil @ Sk Sahid** are hereby remanded to J.C till next date.
