Proxy counsel prayed that it would be appropriate to examine the above witness in the physical presence of all accused persons.

Accused Yashin Bhatkal @ Ahmed Siddibappa has also not been produced before this court either physically or through VC.

In view of the submissions made and in the interest of justice, PW263 Sandeep Singh is discharged unexamined today. **He be summoned again for 30.08.2024.**

Issue Production warrants against accused Yashin Bhatkal @ Ahmed Siddibappa with directions to produce him through VC on NDOH.

PW279 Insp. Ravinder Kumar Tyagi be summoned for 02.08.2024.

MHC(M) be also summoned for NDOH alongwith relevant case property.

All the accused persons are directed to be produced physically before this court on 30.08.2024 for the purpose of their identification by the witnesses. Production Warrants be issued accordingly. Copy of this order be also sent alongwith the production warrants of accused persons for necessary compliance.

As prayed by accused Hakim, he is permitted to appear through VC on NDOH.
