Ld. Advocate for the defence side is present. Ld. Spl. P.P is present with C.D.

Today is fixed for hearing of the bail petition u/s.439 Cr.P.C dt.09.11.2022 in respect of accused Nanu @ Arun Rajowar in presence of the defacto complainant.

Ld. Spl. P.P has submitted that the defacto complainant of this case has appeared before this court and has filed the hazira of the defacto complainant who is personally present before this court now.

Said bail petition u/s.439 Cr.P.C dt.09.11.2022 is taken up for hearing.

Heard both the sides. Considered.

At the time of hearing, Ld. Advocate for said accused person has prayed for bail for said accused and has submitted that the only allegation against the present accused is that at the time of the alleged incident he along with another accused, who is a juvenile, forcibly dragged the victim girl to a distance and outraged her modesty and that this accused is in custody since 06.08.2022 and that in this case the investigation is over and the I.O has submitted the C.S.

Ld. Spl. P.P has submitted that in the instant case the V.G. has made statement U/s.164 Cr.P.C and that there are incriminating materials against this accused in the C.D.

On perusal of the materials in the C.D, it appears that the I.O has submitted C.S U/s.8 of the POCSO Act and that this accused is in custody since 06.08.2022.

Considering the entire facts and circumstances stated

above and considering the period of detention of the accused in the custody, **the instant prayer for bail for the accused person is hereby allowed and said accused namely Nanu @ Arun Rajowar may find bail of Rs.4,000/- with 02 registered sureties of Rs.2,000/-each subject to the satisfaction of the Ld. Chief Judicial Magistrate, Purulia, i.d. to J.C. till 14.12.2022.**

Today is also fixed for consideration of charge.

Ld. Spl. P.P has filed one petition praying for adjournment for hearing of charge on the ground stated therein.

Heard both the sides. Considered.

The prayer for adjournment of hearing of charge is hereby allowed.

If on bail to 09.05.2023 for appearance of the accused person namely Nanu @ Arun Rajowar and for consideration of charge.
