Ld. Spl. P.P. has raised objection to the instant prayer for bail of the present accused and has submitted that in this case the statement of the victim girl u/s.164 Cr.P.C. has been recorded during investigation and that there are incriminating materials against the accused in the case diary.

On perusal of the materials in the case record as well as C.D., it appears that the alleged offence is S.8 of the POCSO Act and that during investigation the statement of the victim girl was recorded u/s.164 Cr.P.C. Perused the materials in the C.D. including the statement of the victim girl recorded U/s.164 Cr.P.C.

Considering the materials in the C.D. including the statement of the victim girl u/s.164 Cr.P.C and the stage of investigation, **the instant prayer for bail u/s.437 Cr.P.C of the present accused person namely Nanu Rajwar is hereby rejected at this**
