Accused **Subhash @ Subhas Karmakar** is produced before this Court today from J.C.

Ld. Spl. P.P. and Ld. Defence Lawyer are also present.

Today is fixed for appearance of the accused persons and for consideration of charge. The case record is taken up accordingly.

Perused the materials on record as well as on the C.D. Heard both the sides. Considered.

Learned PP-in-charge has opened the prosecution case and has submitted that on 30.06.2022 about 07:00 hrs. near the village pond at village- Rajdih under P.S.- Barabazar, Dist.- Purulia, you voluntarily caused grievous hurt to the victim girl (15 yrs), the minor daughter defacto complainant, by pressing her throat and by assaulting her with such intention and under such circumstances if by that act you had caused the death of of said victim girl and that this accused committed aggravated penetrative sexual assault to said victim girl and that there are sufficient materials in the C.D to frame Charge U/Ss.325/307 IPC and also charge U/s.6 of the POCSO Act alternatively U/s.376 IPC against accused **Subhash @ Subhas Karmakar**.

Considering the materials in the C.D and considering the submissions of both the sides, I am of the considered opinion that there are sufficient prima facie materials in the C.D against the present accused persons to frame Charge U/Ss.325/307 IPC and also charge U/s.6 of the POCSO Act alternatively U/s.376 IPC against accused **Subhash @ Subhas Karmakar**. There is no prima facie materials to frame charge U/s.506 IPC.
